A rent receipt template is a form that allows a tenant to mark their monthly rent as paid. Most commonly for the use of cash payment by the tenant to their landlord. The receipt should only be filled in after the funds have transferred to the landlord. The form may be issued on-the-spot with the landlord completing the amount and how the payment was made. Security Deposit Receipt - Use when a tenant makes an initial deposit to the landlord at the start of a lease. Table of Contents A rent receipt is an acknowledgment of payment made by a tenant. This is usually in the form of cash but can be for credit cards and physical checks as well to show the tenant paid-on-time. The receipt consists of the amount paid, property address, payment source, and most importantly the landlord's signature. How it Works The tenant pays the rent, in accordance with their rental agreement, to the landlord. If a receipt is needed then the payment is usually done in cash. The landlord will then write the amount paid and for the rental period. Step 2 - Landlord's Signature It is imperative that the landlord sign the receipt as it is the only proof the tenant will have that rent was paid. Step 3 - Keeping the Receipt The tenant will be handed the receipt and should be stored safely in the chance the landlord tries to bring a claim for non-payment. Especially with most sites offering it as a free service to try and obtain the landlord as a customer for performing tenant screening (background and credit reports). As a landlord, this is very easy to set up and only requires signup and uploading their bank documents. In April 2017, an income tax tribunal ruling on rent receipts grabbed many eyeballs. This is because it rejected the HRA exemption claimed by a salaried individual for the rent paid to her mother. The tribunal rejected the claim on the grounds that there is no proof to substantiate that payment of rent has actually happened apart from rent receipt which could have been easily obtained by the taxpayer from her mother without paying the rent. Here are some list of documents and dos and don'ts which you must remember while claiming tax exemption of HRA from your employer or while filing income tax returns (ITR). 1. You have must have a valid rent agreement. The rent agreement must mention all the relevant details such as amount of monthly rent, time period of rent agreement, any utility bills to be paid by you etc. Archit Gupta, CEO & Founder of Cleartax.com says, "Make sure that there is a signed agreement between you and the landlord even if they are your parents. The agreement must mention the premises rented by you, other charges such as utility or property tax if payable by you. " 2. In case of a shared accommodation, then along with the above mentioned details in the rent agreement, it should also mention number of tenants co-sharing the flat, ratio in which rent and how utility bills are to be divided. 3. Make your rent payments preferably via banking channels instead of cash. Using banking channels helps to provide an electronic trail of money for the transactions occurred. 4. You must ask for receipt for the rent paid every month irrespective of the channel used for making payments. Pinky Khanna, Director, People Advisory Services, EY India says, "It is mandatory to furnish rent receipts to the employer for claiming HRA exemption for the monthly rent paid more than Rs. 3000 per month. " 5. In addition to rent receipts, if your payment exceeds Rs. 1 lakh annually, then it is mandatory for you to provide the PAN of your landlord to your employer to avail the full benefit of HRA exemption. It helps you to lower your TDS deduction. 6. In case PAN is not available, then your landlord must be willing to give you a declaration to this effect. Confirm this before taking house on rent so that you are able to avail the benefit of HRA exemption from your employer. Along with the declaration, you also need to obtain 'Form 60' dully filled by your landlord, in case PAN is not available. You need to submit these to your employer. 7. 'If you do not provide PAN of your landlord then, you cannot claim tax exemption for HRA from your employer while withholding TDS on salary. While Income Tax Act does not restrict the employee from claiming tax exemption for HRA while filing returns but there will be mismatch in the salary income reported in the Form 26AS by your employer vis-à-vis that reported by you in your return. This may prompt the department to send a communication seeking response regarding the mis-match', says Khanna. 8. There might be circumstances where an individual pays higher rent than what is actually mentioned on the rent agreement and difference is paid in cash. If that happens, tax exemption will be calculated only on the basis of rent receipt furnished by employee mentioning the amount paid. Any amount paid over and above the rent receipt shall not be considered for the purpose of exemption by employer, warns Khanna. 9. Gupta further adds that that you must physically reside in the house mentioned by you while claiming HRA exemption. In case your parents are landlord, make sure that they include the rental income too while filing their returns. 10. Remember to deduct tax at source (TDS) @ 5%, from the rent paid to your landlord if you are paying rent above Rs. 50,000 per month. Interest at 1% per month is levied in case you forgot to deduct it and 1.5% per month where TDS is deducted but not deposited. It would also attract the penalty of Rs 200 per day for the period of delay, says Khanna. You can claim tax exemption up to 100% of the actual HRA received provided all the conditions to claim relief have been satisfied by you. This is the time when most employees get frantic and check with their friends or colleagues about the best way to arrange these receipts. Most employees do not understand why these rent receipts are important or how they help you save tax.If an employee wants to claim income tax benefit on House Rent Allowance (HRA), he/she has to provide the proof of payment of rent to the employer. In this regard, rent receipts serve as evidence. Basis the receipts submitted, the Indian Government provides deductions and allowances to the employee.In case you are a salaried professional and you live in a rented house, you can avail HRA exemption to save tax under Section 10 (13A) of the Income Tax Act. For those who are self-employed, they can avail HRA tax deduction under Section 80GG.The lowest of these 3 components will be a part of your Exemptions, in Income Tax Calculation. Your final tax liability will be calculated based on the exempted HRA amount.As explained above, a salaried employee has to submit a rent receipt as a proof of rental expenses to his company - this is in accordance with the Income Tax Act, 1961. A rent receipt is provided by the landlord when he receives the rent from the tenant - it has his signature that confirms the receipt of payment. If you are paying rent, you can submit evidence and save tax - total amount is reduced from your gross taxable income. Some other elements that could be a part of the receipt include: PAN of the landlord, if annual rent exceeds ₹1,00,000 in a year and Revenue Stamp (where amount exceeding ₹5000 is paid).What is HRA?As the name suggests, HRA or House Rent Allowance is the amount paid by employers to employees, as part of their salaries.How is HRA calculated?The calculation of HRA is dependent on several factors - this includes entitlement to 50% of the basic salary, if the employee resides in a metro city and 40% if it's a non-metro city. The calculation of HRA to avail tax benefit is considered from any of the three below-mentioned provisions:The actual rent that is paid should be less than 10% of the basic salaryIf you're staying in a metro, 50% of the basic salary and 40% if you live in a non-metro cityThe actual amount allotted by the employer as HRA.The least of the aforementioned amounts will be considered for tax deduction.What is a rent receipt?A rent receipt documents rent payments between the tenant and landlord. It includes important information, including the amount of the rent, the date of the payment received, and the medium of transaction.Is the landlord's PAN number required in a Rent Receipt?If the annual rent paid exceeds ₹1,00,000, it is important to obtain PAN of the landlord and share it with the employer to claim HRA exemption. If the landlord does not have a PAN, get a declaration from the landlord with his/her name and address. In the U.S., many states require landlords to provide tenants with rent receipts, free of charge, whenever they are requested. This rule may also apply to previous tenants who can request receipts within one year of having moved out.You will need to review your state or country's laws to verify if providing a receipt is mandatory or required only upon request by the tenant. Failure to provide rental receipts when it is required by law can result in the filing of complaints by the tenants to local authorities, and fines being assessed against you. For most individuals, your monthly rent is one your highest expenditures, so being able to document proof of payment is important for many financial reasons. In addition, requesting a rent receipt is not only a wise financial move, it may be one of your tenant rights, depending on the state you live in.Immediately request a copy of your rental receipt once payment is madeKeep a copy of each receipt for your records and in a safe placeEnsure that all required and necessary information is complete and accurateAccept rental receipts from unauthorized partiesForge! to request additional items that are included in your rental payment be itemized to avoid disputes (e.g. utilities, cable, etc.)Wait to have any errors or inaccuracies correctedKeeping your rental receipts is important for:Verifying payments, particularly those made in cash. Having your rental receipts can help show that you have a positive payment history or can help you to dispute discrepancies that may appear on your credit report.Dispute settlement- In the event there is a discrepancy regarding your rental payments (e.g. late, partial or no payment disputes), having a copy of rental receipts can help sort out and avoid possible issues, including late fees, evictions, and negative reports on your credit.Help! I Am Unable to Obtain a Rental ReceiptIn cases where your landlord or property management company state they are unable to provide you with copies of rent receipts, it's important that you verify whether they are legally obligated to do so.
